

# Terms and Conditions

- These terms are effective by opening a new account with Vinson Financials Ltd whereas under this offer, the client acknowledges they have read and agreed to be bound by these Terms and Conditions and Vinson Financials Account Terms.
1. To be eligible you must be a genuine new client of Vinson Financials that opens a new live account (meaning, not a “demo” account) via the relevant banner on the website [www.afghanfxmarket.com](http://www.afghanfxmarket.com) or any other link(s) regarding the current offer.
    - 2a. For the purpose of this offer, a new client will be regarded as an applicant or a close affiliate of an applicant who has never registered to apply for a live account with Vinson Financials and now, is accepted by the company .Vinson Financials will in its sole discretion determine whether an applicant is a genuine new client by assessing whether the applicant is associated or affiliated with any other existing account holder with the company, including those with previously closed accounts.
    - 2b. Clients who have already inactive accounts with Vinson Financials (Inactive refers to accounts with no trades taken place for 3 months or more) are also eligible for this offer.
  3. Each applicant is only permitted to open one trading account with Vinson Financials

15. Vinson Financials will not be liable for any margin call or losses that you may suffer, including but not limited to losses due Stop-out Level, if it occurred before the maturity date of the cash back to be placed in the client's account.

### **Additional Conditions**

1. This offer is limited to one applicant per IP address.
2. You must be over 18 years of age to register to apply for an account.
3. If Vinson Financials suspects a client has abused or attempted to abuse this offer to the detriment of the company beyond the intention of the offer, then Vinson Financials may deny, cancel or withdraw the offer to that client, and either temporarily or permanently terminate that client's access to the online services and suspend or close the client's account.
